

General

- Tentative bookings may be held for 21 days prior to the cruise date
- Cruises are confirmed when the required booking fee 20% of total function cost is received. Monies to be paid must be paid by forwarding bank cheque, money order to PO BOX 6488 North Ryde NSW 2113 or paid in cash by prior arrangement.
- For private or group cruises - all monies need to be paid 14 days prior to the cruise date and final numbers need to be advised.
- For any bookings made via the web-site, the user must be over the age of 18 years or supervised by a parent who agrees to the contract and the minor's use. The user must be truthful in information disclosed on the site and agrees to what he/she is booking and agrees to pay for it.

Refunds

- If the cruise is cancelled by Fusion Cruises (FUSION CRUISES) due to mechanical, safety, weather or reasons beyond our control, FUSION CRUISES will refund payments made. No additional refund or compensation will be given.
- Booking fees are only refundable should Fusion Cruises be able to replace your charter with another of similar value, then your funds paid will be refunded less a \$200 handling fee. If you wish to reschedule to another date, a new deposit must be paid, any previous paid amounts will be refunded less \$200 fee only if or when a replacement charter of similar value can be obtained for the original function date.
- Booking fees are only refundable on private charters, if cancellations are received at least 60 days prior to the booking date.
- For group bookings, which do not involve a private charter, 30 days is required for cancellation.
- By booking or signing the confirmation order you confirm that you have inspected the vessel or made arrangements to that effect to ensure that the vessel meets your requirements
- In special events such as Christmas Function high peak season (15th Nov to 31st Dec) and calendar marked festive season events such as New Year's Eve, Christmas Day, Boxing Day, Australia Day, no refund for cancellation is available.
- No refund is given for "No show guests"

Departing

- We recommend that your guests be advised to arrive at the pick up point at least 20 minutes before the designated time to avoid disappointments. Water taxi transfers for late guests can be arranged but are generally discouraged
- Cruise details will be confirmed with booking. FUSION CRUISES reserves the right to change the departure schedule at any time as necessary due to weather conditions or other reasons. FUSION CRUISES reserves the right to cancel tours, itineraries and days of operation as required.

Wharf Fees

- Fusion cruises can pick up from most commercial wharves on Sydney Harbour
- There is a fee charged for the use of NSW Maritime wharves. This fee is past to clients who choose to utilize these wharves, our quotes do not include the

booking fee for these wharves these includes King St Wharf, Casino, Campbell's Cove, Ives Steps, Man O War.

Safety

- In the interests of safety no smoking is permitted on all areas of the first level, second level and other enclosed areas of the boat.
- Top deck area is limited to a maximum of 83 persons at a time, no one is allowed outside the rails area.
- No intoxicated person will be permitted to board the boat.
- For your own safety and comfort, high heels are not recommended.
- Fusion Vessel has a maximum capacity of 400 passengers.
- The Captain of the vessel is in charge and has complete authority of the vessel and passengers.

Breakages

- The charterer shall be liable for any damage to the vessel, furnishings and equipment caused by himself, and any member of his party or invitees at cost plus 35% handling/management fee.

Children

- Children under the age of 2 years are free. Children under the age of 12 are charged a half the adult rate. Children under the age of 18 years are charged half the beverage component and receive a full adult meal. All children must be accompanied by an adult responsible for their safety.

Special Notes

- All costs are quoted in Australian dollars and include G.S.T. FUSION CRUISES reserves the right to amend charges of service as required.
- Concession fares, where quoted, apply to Full Time Australian & New Zealand students and pensioners. Proof of identity must be shown.
- Children's fares apply to children to under 14 years of age. All children must be accompanied by an adult responsible for their safety.
- Any breakages or damages must be paid for.
- No food or beverages may be brought onto the boat unless written authorization from Fusion Cruises Management is given.
- FUSION CRUISES reserves the right to refuse entry to persons intoxicated, any person engaged in inappropriate and illegal activities will be asked to disembark at the nearest wharf.
- Passengers accept and acknowledge embarking on this vessel at their own risk, and FUSION CRUISES will not be liable or responsible for any injury or death to passengers arising or due or partly due to some negligent act or omission by FUSION CRUISES or its staff.
- Any Bond refund, as applicable, will be paid/mailed 48 hours after the function, subject to satisfactory inspection for damages.
- Payment of booking fee constitutes acceptance of the above terms and conditions.
